Angelo has over 17 years of international experience with Saipem, from offshore roles to leading HSEQ strategy and operations for complex turnkey projects across the North Sea, Europe, APAC, and the Middle East. He holds a master's degree in environmental engineering.

Graham also thanked the outgoing Board members — Flaubert Matos Machado, Head of Health, Safety and Environment, Petrobras and Helder Silva, Government Affairs & External Relations Director, Azule Energy; for their valuable contributions and commitment.
